Marcus Flavin is primarily a private client barrister. His practice covers trust, probate, and family provision litigation; applications to court by trustees and executors for approval and directions; and non-contentious advice and drafting, (including tax). He has also worked on divorce cases where family trusts are in issue.

He has a particular interest in offshore work, originally arising from an extended secondment to the trusts department of a major Jersey law firm, advising clients on non-contentious trust matters (including pensions) and trusts litigation and has advised on matters in BVI, Cayman, and Guernsey as well as Jersey and Man.

TRUSTS

Marcus is an experienced junior in both contentious and non-contentious trusts work. He has advised on construction issues and exercise of trustees' discretionary powers, disclosure to beneficiaries, and variations. He has also acted in claims for removal of trustees, breach of trust claims, tracing claims, claims that the trust is a sham (including claims arising out of insolvencies) and he has acted for trustees brought into ancillary relief proceedings in the Family Division.

- *English v Keats* [2018] EWHC 673 (Ch) – Acting in a successful claim to remedy defective execution of a power of appointment 18 years ago, by reviving a jurisdiction previously last successfully relied on in England and Wales in 1908 and apparently consigned to history by Park J in *Breadner v Glanville-Grossman* in 2005
- *Representation of G Trustees Ltd & In the matter of the H and J Trusts* [2017] JRC162A – Assisting Jersey advocates for the Trustee in a hotly contested Public Trustee v Cooper application
- *Mills v Mills* [2015] EWHC 1522 (Ch) – Acting on behalf of minors on case concerning construction of a trust deed, retrospective authorisation of a breach of the self-dealing rule, and valuation of interests
- *Perczynski v Perczynski* – Advising trustees of a Jersey trust on litigation disclosure and other issues arising out of long running matrimonial litigation in Poland, France, and Canada

- *Wright & anor v Gater & anor* [2011] EWHC 2881 (Ch) – Acting on behalf of a minor in an application for approval of a deed of variation made on a double intestacy for tax and other reasons
- *Adelaide Partners & ors v Danison & ors* [2011] EWHC 4090 (Ch) [2011] AllER (D) (01) (Mar) – Acting for the wife of the principal defendant in a breach of trust claim arising from an advance fee fraud in the sum of some \$16.5 million, on allegations of dishonest assistance and knowing receipt of the proceeds of the fraud

WILLS AND ESTATES

Marcus is an experienced practitioner in the fields of trusts, administration of estates, probate claims, non-contentious probate proceedings (caveats, citations, applications and summonses) and claims under the Inheritance (Provision for Family and Dependents) Act 1975. He is equally at home in dealing with such matters in the Chancery Division, in the County Court, or in the Principal Probate Registry.

Marcus is recommended as a leading junior in the Private client: trusts and probate section of The Legal 500.

- *Musson v Bonner* [2010] WTLR 1369 – Acting in a claim turning on the presumption of advancement, where the deceased and her son had opened a joint bank account
- *Organ & Another v McKeachie & Others* [2008] EWHC 2661 (Ch) successfully defending a claim that a will should be pronounced against on grounds of want of knowledge and approval said to arise from alleged forgery of a letter of instruction
- Successfully contesting an application for permission to bring a claim under the 1975 Act out of time.

INTERNATIONAL

Marcus often undertakes work offshore, particularly in relation to trusts.

Earlier in his career he spent 8 months on secondment to the trusts department of the Jersey firm of Bailhache Labesse where he drafted trust instruments and advised on a wide variety of contentious and non-contentious work.

His cases and work of note in this area include:

- Assisting Michael Heywood in advising the plaintiff in *Re Teighmore* (the “Shard of Glass” litigation) in Jersey
- Assisting the Jersey Law Commission in preparing their report on the Jersey Law of Partnership.

TAX

Marcus advises on inheritance tax, capital gains tax, and the income tax treatment of trusts and estates, and often advises on and drafts instruments of variation under section 142 of the Inheritance Tax Act and section 62 of the Taxation of Chargeable Gains Act. He is also experienced in court applications where the consent of the court is required for such a variation. He has also been involved in tax litigation with an insolvency angle.

In 2011, Marcus acted for the *Revenue in the Court of Appeal in HMRC v Chamberlin* [2011] EWCA Civ 271, a claim by the bankrupt to annul her bankruptcy on the basis that the VAT returns on which the petition had been based were said to be incorrect. This was an appeal by the Revenue from the order of Mr Donaldson KC, who had granted an appeal from the original order of Chief Registrar Baister and had granted the annulment. The Court allowed the appeal and reinstated the bankruptcy order.
